### **PROCLAMATION**

- WHEREAS, the 50th Anniversary of the National Fair Housing Law, Title VIII of the Civil Rights Act of 1968, during the month of April, is an occasion for all Americans individually and collectively to rededicate themselves to the principle of freedom from housing discrimination whenever it exists; and
- **WHEREAS**, this law guarantees for each citizen the critical, personal element of freely choosing a home; and
- **WHEREAS**, a fair housing law has been passed by the state of Louisiana, and implementation of the law requires the positive commitment, involvement, and support of each of our citizens; and
- **WHEREAS**, the department and agencies of the state of Louisiana are to provide leadership in the effort to make fair housing not just an idea, but an ideal for all our citizens; and
- **WHEREAS**, barriers that diminish the rights and limit the options of any citizen to freely choose a home will ultimately diminish the rights and limit the options of all.

**NOW, THEREFORE**, I, John Bel Edwards, Governor of the State of Louisiana do hereby proclaim the month of April 2018, as

### **PROCLAMATION**

Whereas, the week of April 2 - April 6, 2018 has been designated as National Community Development Week, <u>Red River Parish</u> has been a participant in the Community Development Block Grant (CDBG) Program which funds public infrastructure, economic development, and housing programs in this community, and

Whereas, in this community and communities throughout the nation, forty- four years of Community Development Block Grant Program funding has developed a strong of relationship between this local government and its residents, principally those of low-to-moderate income, and

Whereas, this community recognizes that the Community Development Block Grant Program is a partnership of federal, state, and local government and community and business efforts, and that the services funded by the CDBG Program relies heavily on the dedication and good will of our combined efforts,
