On the motion of Mr. Brown, seconded by Mr. Moore the 2021 Millage Resolution was adopted by the follow roll call:

RESOLUTION

BE IT RESOLVED that the following millage(s) are hereby levied on the 2021 tax roll on all property subject to taxation by Red River Parish Police Jury.

BE IT FURTHER RESOLVED that the proper administrative officials of the Parish of Red River, State of Louisiana, be and they are hereby empowered, authorized, and directed to spread said taxes, as hereinabove set forth, upon the assessment roll of said Parish for the year 2021, and to make the collection of the taxes imposed for and on behalf of the taxing authority, according to law, and that the taxes herein levied shall become a permanent lien and privilege on all property subject to taxation as herein set forth, and collection thereof shall be enforceable in the manner provided by law.

The foregoing resolution was read in full; the roll was called on the adoption thereof, and the resolution was adopted by the following votes:
