BE IT RESOLVED THAT the following millage(s) are hereby levied on the 2025 tax roll on all property subject to taxation by Red River Parish Police Jury.

PARISH TAX: EXEMPTED MUNICIPALITIES	2.20
RED RIVER PARISH LIBRARY	8.13
RED RIVER PARISH HEALTH UNIT	2.42
RED RIVER PARISH POLICE JURY PFMF	3.63
RED RIVER PARISH COUNCIL ON AGING	1.15

BE IT FURTHER RESOLVED that the proper administrative officials of the Parish of Red River, State of Louisiana, be and they are hereby empowered, authorized, and directed to spread said taxes, as hereinabove set forth, upon the assessment roll of said Parish for the year 2025, and to make the collection of the taxes imposed for and on behalf of the taxing authority, according to law, and that the taxes herein levied shall become a permanent lien and privilege on all property subject to taxation as herein set forth, and collection thereof shall be enforceable in the manner provided by law.
